A total of 41 interviews were conducted between November 2019 and June 2021. Fieldwork initially consisted in face-to-face to interviews, but the outbreak of the Covid-19 pandemic forced me to conduct interviews either via phone or online, according to the choice of the individual party representative. The choice of carrying out remote interviews was taken for safety reasons after the first local lockdowns in Lombardy and Veneto were enforced on 23 February 2020. Interviews were conducted in Italian and typically lasted between 1 and 1.5 hours. They were digitally recorded with the consent of the interviewee, and the data were collected, stored, and de-identified in line with the ethical procedures of the institution to which I belonged.
